

LCCS friends and families have access to the easiest fundraiser ever. You can earn money for the school simply by shopping! By spending what you normally spend on food, clothing, entertainment, gasoline, and dining out, you can make a financial contribution to the school and lower your tuition too.

The only thing required is that you first purchase gift certificates/cards from the local and national vendors that you regularly patronize. The gift cards are ordered online at www.shopwithscrip.com, payment is made directly to the school by money order or check (payable to Lancaster County Christian School), and gift cards are picked up at the school.

Order forms (printed from the scrip website) and payment must be submitted to each campus receptionist by Monday at 8:30 a.m. each week. Certificates can be picked up or will be sent home with students at the end of the week. LCCS profits as a result of the discount that retailers give to the school for each purchase. Of the money that LCCS earns, 50% goes to the school and 50% goes toward the family's tuition. Friends and relatives who do not have children attending LCCS may designate the tuition account to which they want money applied. Tuition credits are issued in January and June.

Lancaster County Christian School Scrip Program Rules and Guidelines

1. All certificate orders must be accompanied by a check or money order made payable to Lancaster County Christian School. Please do not send cash.
2. Scrip certificate payments are not tax deductible because you receive dollar for dollar value.
3. If your check is returned because of non-sufficient funds (NSF), you will be charged a \$25 fee payable to Lancaster County Christian School. After two NSF checks are tendered on your account, your scrip ordering privileges will be limited to payment online or money order only.
4. Scrip certificates are purchased on your behalf, and are not returnable.
5. When you pick up your scrip certificates, open your order and verify its accuracy. Your signature on the Weekly Order Pickup List (printed from your online order) indicates you have received your order in its entirety.
6. In the unlikely event you should find a discrepancy in your scrip order, please contact the Lancaster County Christian School's Scrip Program coordinator for your campus within 7 days.
7. Scrip certificates are the same as cash, and should be handled accordingly. Lancaster County Christian School will not be responsible for certificates that are lost, stolen or misplaced while in your possession.
8. You must sign a WAIVER OF RESPONSIBILITY form before certificates will be mailed to you or released with your child. These forms will be kept on file, and Lancaster County Christian School accepts no responsibility for certificates delivered in this manner.
9. Participating families' tuition accounts will receive their 50% of revenue earned in January and June.
